**TERMS AND CONDITIONS:** The undersigned does hereby make application to the Suds Factory Car Wash for a membership as referenced above and hereby agrees to comply with and be bound by the Terms and Conditions, as they currently exist and may hereafter from time to time be amended or supplemented. The member agrees to pay the monthly dues for the membership referenced above which may be subject to increase as described below. Membership is only valid per vehicle enrolled on reverse side of agreement.

By executing the "membership" agreement on the front of this form you have authorized us and or our agents, to make withdrawals from or apply other related agreed upon charges to the account you have specified for membership dues. You further indicate by your signature as member, that you are an authorized signatory of the account specified for use in the collection of those same dues and fees. You understand that the above authority is to remain in force and in effect for the monthly payment amount as indicated on the front of this Agreement, on a month to month basis, or until such time as (1) Suds Factory Car Wash terminates the program, or (2) Suds Factory Car Wash receives written notification from you informing us of your intent to terminate Membership. In any event, you understand that Suds Factory Car Wash will act promptly to stop further debit entries within a reasonable period of time herin defined as no longer than 10 days from the date Suds Factory Car Wash receives such written notice.

**MONTHLY DUES:** Monthly dues will continue to be collected each month, on the first day of the month the contract was entered into regardless of the membership usage of the affiliated car wash until we are notified in writing that you wish to cancel this agreement. Regardless of such cancellation, any outstanding balance of the membership fee will remain due and payable in accordance with this agreement. You may pay the monthly dues in advance for a full year as annual dues, and receive one month of membership free of charge. If you fail to pay any monthly dues payable within 30 days after the date such payment is due, your membership privileges may be canceled and you may have to reapply for membership under new terms and conditions.

**CANCELLATION:** The member may cancel this agreement at any time. Written notice of cancellation is required at least 5 days prior to the last day of the month. Non usage does not stipulate cancellation or a refund. Cancellation notices must be sent to Suds Factory Car Wash, Attention: Loyalty Program, 9171 E. Westview Rd. Lone Tree, Co. 80124.
